2026/02	Public Participation: Shropshire Footpath Partnership <ul style="list-style-type: none">Mike Webb, Chair Boraston Parish Meeting, is leading on creating a collaborative approach to the maintenance and management of footpaths in Nash and Boraston parishes for the benefit of allThis will involve attending training provided by Shropshire Council and subsequent support of the Footpaths Officer over a 6 month period thereafterIt is proposed that a joint working party be established to include 2-3 volunteers from Nash Parish to join the Boraston volunteers to be trained in the necessary skills, including repairing stiles, inserting kissing gates etc. These people will then, in turn, pass these skills on and lead regular working groups to clear and maintain footpaths in the 2 parishesKey is getting local farmers and landowners on board with a view to creating a circular route which is easy access and potentially less intrusive and disruptive to farmers and sown fields, which may include diverting established footpaths and replacing with permissive routes.The question of who will bear the cost of diversions, signage etc. was raised and is to be explored with SC Footpaths OfficerNash Parish Council fully supports the proposal in principle and Mike Webb to provide more detailed information and communication to send out to the community with a view to recruiting volunteers. 	<p>the tower, spire and south nave roof at Nash Church, which will secure its removal from the Heritage At Risk Register.</p> <ul style="list-style-type: none"> Grant covers 84% of total project cost, including funding for a range of environmental, social inclusion, access and legacy projects as well as a sizeable contingency to cover unforeseen problems that might come to light during the build. The PCC has had to raise remaining 16% in match funding, and thanks to grants from the Friends of Nash & Boraston Churches, Shropshire Historic Churches Trust, Lasletts Charities and the Benefact Trust they are confident the remaining funds will be raised. Projected start date April 1st 2026. Appointed contractors are Ludlow firm Dan Paddock Building Solutions Ltd, due on site midsummer. 2 launch events planned at Nash Village Hall and Nash Church in February and March, with the dates and details to be confirmed after the PCC January meeting.
